


"There's a Place for you at our Table"


"You are the frontlines--no matter where or how you serve."

It began as a personal memoir for her son. Reflecting on her **ten years of post 9/11 military service**, Marjorie K. Eastman wanted to capture the lessons and inspiration she'd learned serving beside men and women who represent the very best of what it means to be American. And these service members represent just 1 percent of the American public. Eastman identifies this group as the Frontline Generation and notes it is an untapped reservoir of leaders--now back in our communities--who have been strengthened by the unique difficulties of post 9/11 service.

The compelling journey of Marjorie's time in uniform culminates in her final assignment, when she was responsible for the lives of over 100 troops--men and women--scattered throughout Eastern Afghanistan. Her first-person account of that time is a moving story from personal commitment to the conviction that service--no matter where or how--is the best path to success. She offers lessons on life, leadership, service, and the way for every person to find a role in them.

Marjorie's journal entries further reveal frustrations, inspiration, joy, heartbreak, laughter, purpose, resolve, and the remarkable ways service members came together to solve problems and break boundaries. She defines the legacy her Frontline Generation leaves on this country, and encourages readers to think about who they want to be, how they can make a difference, how they can make their lives count. Service is the key.

Marjorie's book abounds with wisdom, compassion, and humor. She will have copies available at the meeting and will be glad to sign for you.



She served ten years as a United States Army Intelligence Officer and Commander, which included two combat deployments, and nearly a decade with the world's largest defense contractor, Lockheed Martin Corporation, where she managed

planning and implementation of new business and program growth activities. Eastman earned her M.B.A. from Vanderbilt's Owen Graduate School of Management and most recently served as a Fellow with The Mission Continues, a non-profit organization dedicated to empowering veterans to serve their country in new ways.

Marjorie's educational background includes a B.A. in Political Science from the University of California. As an under-graduate, she was competitively selected as a White House Intern and also studied abroad at the University College London, School for Slavonic and East European Studies. Eastman earned her M.A. from the University of Denver/Josef Korbel School of International Studies in International Security, with a concentration in Human Rights. During her graduate studies, she was one of 56 students selected nationally for the FBI's Honors Internship Program. Marjorie resides in Pleasant View, Tennessee. You won't want to miss hearing this amazing story from this distinguished Veteran.

May 1, 2018 County Primary Candidates File Petitions to Run for Offices

There are several offices at stake in the May 1, 2018 Montgomery County primary. Those positions to be filled include County Mayor, County Commission (all districts), Trustee, Sheriff, Circuit Court Clerk, County Clerk and Register of Deeds and many have already filed Petitions to run for those offices.

Some potential candidates are registering as Independents, formally declaring neither a Democratic or Republican affiliation, and those candidates would not appear on the ballot until the August 2018 county general election, assuming they qualify to run.

As Republicans, we need to note those candidates and work to get them elected. Remember, too, those who opposed a Primary. This

chart shows those petitions filed as of December 22, 2017. Qualifying Deadline is Thursday, Feb. 15, 2018 noon and Candidate withdrawal deadline is Thursday, Feb. 22, 2018 noon.

3 cups broccoli florets

1 medium carrot, chopped

1 large onion, chopped

1/4 cup butter or margarine

2 (10-3/4 ounce) cans cream of chicken soup

1 tablespoon chicken bouillon

2 cups sweet milk

Sauté broccoli, carrot, and onion in butter until tender in a saucepan. Add soup, bouillon and milk. Simmer. If you like a smooth soup, puree the mixture in batches before simmering in a saucepan.

Meet the Gubernatorial Candidates

As we discussed in the last newsletter we are attempting to give you some information about a different candidate each month. We have already profiled Mae Beavers, Diane Black, Randy Boyd, and Beth Harwell for you. We continue here with those candidates as we preview each one in alphabetical order.

This does not indicate any type of endorsement for the particular candidate, but is simply for informational purposes so that you can make a better decision about your vote.



This month's candidate featured is Tennessee businessman, **Bill Lee**. The information provided here was taken from his website at <https://www.billlee.com>. You can go to that site to get more information.

As a seventh-generation Tennessean, Bill Lee's roots run deep in this state. Bill was born in Franklin where he still resides today with his wife Maria on his family's farm. He's the proud father of four adult children (Jessica, twin sons Jacob and Caleb, and Sarah Kate) and five grandchildren.

After attending Williamson County Schools, Bill went to Auburn University, where he studied Mechanical Engineering. When he graduated, he returned home to Franklin to join the family business his grandfather started in 1944. Through hard work, Bill learned what it takes to lead a company, doing what is necessary to help build a business and create jobs. He held several roles at Lee Company before becoming President of the company in 1992. Under Bill's leadership, the company grew into a comprehensive facilities solutions and home services company.

Life threw some of the most difficult challenges on Bill when his first wife Carol Ann tragically died in a horse-back riding accident in 2000. He learned how short life is, how every minute counts, and that only a few things in life truly matter. He took a step back from Lee Company to raise their children.

In Bill's absence, the company found itself in a very difficult financial position. Determined not to let his grandfather's company fail, he returned and made tough choices to turn around the business. It was one of the most painful seasons his company ever faced but resulted in a repositioning that put the company on a new course for success.

Now, Lee Company employs more than 1,200 individuals with annual revenues of \$215 million. The company has won numerous awards for work culture and business accomplishments, and Bill was named a "Most Admired CEO" in 2015 by the Nashville Business Journal. With his family's company thriving, Bill stepped back to serve as Chairman of Lee Company in 2016. In 2017, Lee Company was chosen by the Tennessean as the best large company to work for, as chosen by employees.

In addition to his responsibilities as Chairman of Lee Company, Bill is also active in Triple L Ranch, a fourth-generation family farm founded by his grandparents. Triple L Ranch operates a 1,000-acre, 400-head Hereford cattle operation, providing natural beef to farmers markets and farm to table restaurants throughout Middle Tennessee.

With a belief that education can be the gateway to greater opportunities, Bill has served as the 7th Congressional District's representative to the Tennessee Higher Education Commission. He's also on the Board of Trustees at Belmont University.

Bill has a heart for serving others. Bill is the past president of Tennesseans for Economic Growth, past chairman of YMCA of Middle Tennessee, past president of the Associated Builders and Contractors, and has served on the board of several community organizations including Hope Clinic for Women, Men of Valor Prison Ministry, Fellowship of Christian Athletics, Operation Andrew and many others.

Bill is a man of faith, and he and Maria are active in Grace Chapel Church and in numerous faith-based ministries, which have taken him all over the world to serve people in need, including to Africa, Central America, Haiti, and Iraq.
